Greetings All

This past year has gone by fast. As we look back, there have been a few changes. Our 3rd Selectman came on board the end of June. We also started taking credit card payments. The Tax Collector started taking early payments on property taxes. This has made revenue steady instead of larger amounts only coming in at certain times. Our officials have all been changed to appointed at the end of their term. The Officers are still elected.

The TRIO Budgetary package is in full use and we will be seeing the result of our first year the end of June. It has been an uphill challenge for training and for entering all the payables and revenues from last March to present and beyond. Going forward should be much easier with the data already in the system and any new entries will be easy to add using the created templates. Account totals will be much easier to get due to the report writing features in the package.

This year we have been able to collect many overdue taxes as well as help a number of our citizens get back on track making timely payments or assisting them with other avenues to research for help.

The culvert work on Hales Hill Road was successfully completed thanks to the help of a grant and the towns of Brooklin and Sedgwick sharing the expense.

Thankfully we made it through the year so far with no major challenges to our local infrastructure and shoreline. Damage from last year's storms for the most part have been repaired. The town dock repairs were made quickly but it is becoming clear that the tides are rising and something may have to be done to the dock against these rising tides in the future.

As the end of this year comes to a close, we would like to thank Cynthia (Cindy) Reilly for her continued service to the Town of Sedgwick and all it's citizens. She has been part of the Town Office for 35 years. Thank you Colby Pert for all the years off and on the Select Board. We will miss your knowledge and history of the town gained and over your many years of service. We also want to thank all the volunteers and all the people on various committees and boards for their service to the town.

And finally, we want to thank you, the legislative body and citizens of the town for all your continued support.

Dear Friends.

I hope this letter finds you well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. Thank you for the opportunity to share an update on the work I've been doing for the people of the Second Congressional District.

Fisheries: This spring, the Atlantic States Marine Fisheries Commission (ASMFC) announced a gauge increase for lobsters caught in the Gulf of Maine beginning in January 2025. Maine fishermen warned that this decision is founded on incomplete and inaccurate data. Additionally, this gauge increase could put Mainers at a competitive disadvantage to Canadian fishermen with looser regulations. That's why I sent a letter to the ASMFC urging them to delay their decision until they can evaluate data with fishermen, whose proactive stewardship provides invaluable insight. I have also submitted an amendment to this year's funding bill that would block federal funding from being used to implement and enforce a gauge increase. Because of these efforts, the ASFMC made the decision to delay the implementation of this new requirement. I'll always stand with Maine lobstermen against unfair, unnecessary regulations that threaten their livelihoods and industry.

Veterans: The first meeting I attended as an elected official was with a large group of veterans and the former Director of the Maine Bureau of Veterans Services. We discussed a lot, but one issue rose above the rest; how little was being done for Maine veterans who needed treatment for mental health issues or substance use. At the time, there were no in-patient treatment beds in Maine, so veterans had to wait for a bed to open up at an out-ofstate facility. Fast forward 10 years, through unending red tape, and I'm delighted to report we just broke ground on a treatment facility at the Togus VA Medical Center in Augusta. This was the direct result of the tireless advocacy of veterans from across our state — this win is theirs.

Postal Service: This spring, the U.S. Postal Service (USPS) announced plans to consolidate and move some processing operations from the Eastern Maine Processing & Distribution Center in Hampden to Scarborough. This would have caused significant mail delivery delays that disproportionately harm rural communities. That's why I introduced the Timely Mail Delivery and Postal Services Protection Act, which would have halted this planned consolidation across the country. Following these efforts, the USPS announced they have scrapped their plan entirely. While this is a win for Maine, it is also evidence that we cannot become complacent. That's why I recently introduced the bipartisan Postmaster General Reform Act, which would establish term limits for the United States Postal Service's (USPS) postmaster general and require nominations to be confirmed by the Senate. Regardless of the year, one of my top priorities is ensuring I'm accessible to you. My staff and I can help navigate federal programs; find resources in Maine; and resolve issues with Medicare, Social Security, the VA, and other federal agencies and programs. We are here to help:

Dear Friends:

It is an honor to represent Maine in the United States Senate, and I welcome this opportunity to share several key accomplishments for our state from the previous year.

As Vice Chair of the Appropriations Committee in 2024, I have secured nearly \$580 million for 230 projects across all of Maine's 16 counties to promote job creation, workforce training, and economic development; expand access to health care; support law enforcement; improve public education and infrastructure; and protect our environment. As the new Congress begins, I am honored to be taking the helm of the Committee, the first Mainer to do so in nearly a century, and I remain committed to ensuring that federal spending produces real results for our state and nation.

Maine has the oldest average age in the country, which is why I have long prioritized health-focused legislative efforts. There were more than 1,860 health care bills introduced during the 118th Congress. Only 15 health care bills were signed into law, and I was a lead sponsor of five of them. These bills will enhance care for individuals with Alzheimer's, autism, and substance abuse issues through improved research funding, strengthened public health programs, and increased support for rural first responders.

Another important bill that I coauthored was the *Social Security Fairness Act*. Since 2003, when I led the first-ever Senate hearing on the Windfall Elimination Provision and the Government Pension Offset, I have sought to end these provisions of the *Social Security Act* that unfairly reduce the Social Security benefits that public employees or their spouses have earned. I am pleased to say that with the passage of my bill, the *Social Security Fairness Act*, in December, public sector retirees will now receive the full Social Security benefits they have earned.

When the Maine way of life was under threat, I was certain to defend the interests of our state. I worked to protect Maine's potato farmers when the Department of Agriculture tried to reclassify the potato from a vegetable to a grain. I thwarted efforts to consolidate USPS mail operations at the Hampden postal facility, which would have disrupted mail delivery throughout our state. I sounded the alarm with leaders at the FBI and Departments of State and Treasury on the spate of illicit marijuana growing operations that are destroying properties and providing refuge to foreign criminals in our state. Following damage to our working waterfronts after last winter's storms, I secured \$15 million to help fishing communities recover. I championed funding to support the Maine Air National Guard base, Bath Iron Works, and Portsmouth Naval Shipyard.

As of last December, I have cast more than 9,100 consecutive votes, continuing my record of never missing a roll-call vote since my Senate service began in 1997. My ranking as the most bipartisan Senator reflects Maine's tradition of working with a spirit of cooperation and respect.

CEO REPORT

The severe fluke storms in early 2024 did extreme damage to a number of oceanfront properties. The town assisted property owners with D.E.P permitting. Some damaged areas remain to be remediated but most have had significant repairs.

The Harbormaster and Harbor Committee did amazing work in repairing the town wharf, making it functional again, while saving the town a lot of money.

At present there are four new oceanfront homes under construction and around three additional waterfront homes in some stage of construction. The Planning Board is also monitoring and permitting an oceanfront park area at Rope Ferry Rd as well as working with the owner of a former "boatshed" that is being moved and repaired at the shore on Ocean Drive.

Projects outside the shoreland zone do not require special permitting, but do require submission of a \$10 "Building Notification Form." Communities of less than 4,000 in population are not required to employ the otherwise mandated "Maine Uniform Building and Energy Code," albeit area contractors are still held to certain licensing and construction codes that the State has in place and that the lender and insurance industries want to see. If towns signed onto the State Building Code it would add about \$2,000 or more to the cost of a new home and require an "certificate of occupancy" which would be an impediment to most contractors and the "do it yourself" projects.

At present the State is focusing on new "more natural" rules and regulations in larger towns and cities in the State. The idea being to create more affordable housing opportunities.

SEDGWICK BUDGET COMMITTEE REPORT

Feb 10, 2025

The town budget committee met during the winter, primarily using the town's phone conference call system. We reviewed all the non-profit requests by scanning the information submitted for distribution to the committee members, which allowed all members to review the request details. Each organization is asked to provide an indication of the number of Sedgwick residents assisted, the services provided, the fee structure if any, and most importantly the funding sources for their programs. A majority of the organizations provided audited financial statements as well. We met by phone with all who requested sums over \$2000. The deadline for submission of material stayed at December 31st, and this year several organizations that had failed to apply in a timely manner in prior years met that deadline. The social service request form for funding is posted on the town's website under forms.

Our committee also reviewed in person the budget of the town's fire department. The fire department budget under David Carter increased modestly. Given the effects of inflation, the fire equipment reserve account amount was also increased as the department looks to the future as noted at the fall 2024 special meeting authorizing the expenditure of funds to secure a new pumper. The impact of inflation on vehicle and service costs was noted as well in our conversation with representatives from PAC, whose request also includes an ambulance reserve. The school committee bears responsibility for the town's school budget, which is the largest town expenditure.

"Thank you"s are extended to the many community members who volunteer their time for the benefit of the community and the many community members who receive stipends that do not fully reflect the value they provide to our town. Our committee now includes two new members, following the resignation of Robert Lawson and retirement of Horace Wardwell. We encourage citizen involvement. All citizens should make an effort to attend and vote at town meeting. Your vote on town issues could make a difference.

2024 Sedgwick Volunteer Fire Department

2024 proved to continue to be another very busy year for the department. We were paged to a number of incidents with the Deer Isle and Stonington Fire Departments. This agreement among the three communities continues to be mutually beneficial in providing fire protection. Our volunteer fire department responded to 243 incidents for a total of 1160.5 hours and spent 958 hours in training in 2024. The Volunteers also spent many hours at various meetings like, monthly dept. meetings; committee meetings; Hancock County Firefighters Association meetings; as well as attending fire prevention activities, fundraising activities and work sessions.

The department wishes to thank the residents, town officials and taxpayers for your continued support of which is essential to the future of the department. We will continue to strive for excellence in everything we do.

In 2024, thanks to the ongoing support from our taxpayers, and fundraising efforts, we were able to raise enough money to purchase a set of air bags and rescue struts which, once they arrive, will serve us in automobile extrications and other rescue operations.

We will continue to seek and apply for any and all grant funding that becomes available to the department and we look forward all fundraisers; like the annual car show, which has been and continues to be a huge success.

Remember, to reach any emergency services, you must dial **911**. The E911 system is set up to give the dispatchers the exact location an emergency call, thus saving emergency responders critical time by providing better directions to the emergency. Be prepared to answer any questions that the dispatcher may ask. This information is critical for a timely and correct response to the emergency. Please answer the

questions asked and stay on the line until the dispatcher tells you to hang up.

Fire safety needs to be practiced in each and every home. Smoke detectors should be located on each level of your home. They need to be checked, and tested regularly and should be cleaned and batteries replaced twice a year. Smoke detectors should be replaced every 10 years. Develop home fire drills, preplan your escape routes and practice them regularly. Establish a safe meeting area outside the building. If you have any questions, contact the fire department.

Open burning permits are only available online at Maine Open Burn Permit. There is no charge for the permit and it is valid for 24 hours. Remember, you must have a permit to engage in any outdoor burning.

I want to thank our volunteer firefighters for their dedicated service to the Town of Sedgwick and surrounding communities. Our firefighters give a tremendous amount of time and many times risk their lives to protect our citizens and property. Our firefighters do their job for the pride and satisfaction of providing a great service to our town. They are a very dedicated group of people. We are very lucky to have them.

Blue Hill Heritage Trust

Blue Hill Heritage Trust's mission is, "to lead in conserving land, water, and wildlife habitat on the greater Blue Hill Peninsula. To teach and practice a stewardship ethic. To promote ecological, economic, and community health for this and future generations." Much of our work is future-focused, looking to protect and enhance the long-term health of both land and people, and Blue Hill Heritage Trust is committed to both conserving land in our towns and serving those communities.

In 2024 we conserved over 170 acres on the peninsula. About half of this was focused on habitat protection, with one project in Blue Hill and a second adjacent to our Wight's Pond focus area in Penobscot, while the other half prioritized recreational opportunities across the peninsula.

We are still in the process of formalizing an accessible trail at our Ferry Landing Road parcel. Our primary focus here is to keep a large portion of this 15.3-acre parcel wild for the animals and plants, but to have a nice educational and accessible trail for young and old. As we see more development on the peninsula, these wild areas and the corridors that connect them will be increasingly important for protecting the rural character or our towns.

We want to thank all our Sedgwick supporters for being our partners in this work. In 2024, the Trust voluntarily paid \$3,968 in real estate taxes to the town and a total of \$24,603 to all the towns in which we hold land.

We are looking forward to another great year in 2025 and hope to see many of you out enjoying the land and water.

Blue Hill Public Library - Municipal Report for 2024

Hello from the Blue Hill Public Library. 2024 is in the history books and it was a good chapter at BHPL. Below I'll share some information about library funding and usage for the year, but first, let's look at some highlights from the year.

At the beginning of the year, we entered into a new partnership with various libraries around Hancock County, the Hancock County Download Library. Together we are offering a more robust collection of digital magazines, audiobook and eBooks, as well as free access to the *New York Times* digital edition. BHPL offers free access to the *Wall Street Journal* as well. For more information, see our digital services page at www.bhpl.net (where you will also see the recently added Kanopy streaming movie service).

In February we hosted the first annual Groundhog Day Ball in the Adelaide Pearson Room, a new fundraiser for the library. In October we hosted a similar event, a dance with the *Damn*, *Girls!*, which was a fundraiser for both BHPL and the George Stevens Academy library.

We also made some building improvements; some noticeable, and some not. The bulletin board and water fountain area are much improved, with a new hot beverage bar that serves tea and good coffee to library patrons. We added more outdoor furniture and purchased a new portable stage for larger events in the Adelaide Pearson Room.

During the summer, we sponsored a contest to design a new library card, resulting in two new designs that have been very popular.

One of the best aspects of 2024 is that we sailed through the year with the same great staff. We are 15 regular, year-round staff members, including 4 full-time and 11 (at times more) part-time staff, for a full-time equivalent of 8.6 staff members.

Library Funding

The library's operating income comes from three main sources: municipal funding (now 14% of the total, most of which is from Blue Hill, with additional funds from Penobscot, Sedgwick and Surry), annual fundraising (39%, derived from events, the annual fund, etc.) and operating income (47%, primarily from the library's endowment funds). For 2025, the library's operating budget is \$825,794. This provides the peninsula with 55 hours of weekly business hours over 6 days.

Our active Friends of the Library group provides funding for a significant portion of the library's lectures, workshops, and other public events for all ages, as well as items and services not provided by the operating budget, including performances, movies, and other materials. While we think of these things as "extras," BHPL would be a very different library without their contributions. All told, the Friends gave more than \$35,000 to the library in 2024 and has already provided \$15,000 for 2025.



2024 Activities

From a public services perspective, 2024 was very rewarding with the library providing more programs than our 2019-pre-pandemic benchmark. We engaged a record-breaking 10,714 visitors with these programs, answered more reference and technology questions than ever before, and added more electronic resources to meet the growing demand.

Over our 301 service days the library:

- Loaned 95,161 physical and digital items (books, audiobooks, movies, etc.). Use of physical items in the
 library collection decreased by 13% compared to 2023 due to the decrease in Inter-Library Loan (ILL) usage
 resulting from the hiatus of the ILL van service from June to early September. Use of physical materials, not
 including the ILL data, actually increased in 2024 by 2.6%, and digital library use surged with a 35%
 increase over last year—both due to an increase in e-book usage as well as the addition of new services
 such as e-magazines and online access to the New York Times and Wall Street Journal.
- Answered 4,008 reference questions, 443 more than 2023 and over 1,600 more than the 2019 pre-covid level. Library staff also provided 3,932 technology help sessions to patrons, a 9% growth over 2023 and a 183% increase over the 2019 level. Questions are answered in-person, by phone and via email.
- Served 96,665 patrons; approximately equal with our 2023 visitor total. The additional number of patrons
 using virtual services is not measured; however, 618 people registered for new library accounts (cards).
- Hosted 18,851 WiFi sessions, a 20% growth from 2023's total, while use of the library computers (3,404) decreased by 15%.
- Sponsored 599 cultural programs that attracted 10,714 attendees. This attendance is roughly equal (+0.3%) to 2023's total and over 370 (+3.5%) more than the 2019 attendance figure.
- Community-sponsored events (meetings, etc. that take place at BHPL but are not hosted by the library) totaled 599, with an attendance estimate of 4,011. These events increased 12% and attendance increased 28% over 2023. The 599 total is 23% greater than the community usage pre-Covid in 2019.

It is our honor to provide the community with professional library services, particularly in this day and age when such services are decreasing in many parts of the country. Thanks to our diverse funding model, this is accomplished with minimal impact on taxpayers and, we hope, maximum benefit to the entire Blue Hill Peninsula.

We end this report with a public "thank you" to Marcia Schatz, who sadly passed in June of 2024. Marcia served the library ably for years, both as a Trustee and later as Library Director, and was one of the major forces behind the renovations and expansions of 1999-2001. The library is much improved because of her thoughtful stewardship.

Comprehensive Plan Committee Report

A comprehensive plan serves as a road map for sustainable and balanced development, ensuring the long-term resilience, vitality, and rural character of a town.

Sedgwick adopted its first comprehensive plan in 1974, completed a detailed revision in 1980, and created a new comprehensive plan adopted by the legislative body in 1993. Today, in coordination with the Town of Sedgwick Planning Board, development of an updated comprehensive plan is underway. Benefits of an approved plan include: providing legal protection for our ordinances, helping the town qualify for preferred status with competitive state grant programs, guiding state growth-related capital investment towards locally chosen growth areas, sustaining rural living, preserving an environmentally healthy landscape, balancing economic prosperity and quality of life, protecting working waterfronts and community farms, and providing a basis for sound decisions in town management To comply with Maine's Growth Management Act (30-A M.R.S.A §4312-4350) and the state's Comprehensive Plan Review Criteria Rules, the Sedgwick Comprehensive Plan Committee (CPC) and Levine Planning Strategies continue to work with North Star Planning on the required inventory sections (categories) for the town's plan. Phase I of the Comprehensive Plan (CP) was completed in March 2024. Phase I includes the following activities and deliverables:

- CPC administered paper/online survey Summer '23
- CPC posted survey results on town website Fall '23
- CPC initiated presentation by the Maine Department of Inland Fisheries and Wildlife's "Beginning w Habitat Program"- Fall '23
- CPC initiated presentation by Genesis Fund "Housing Issues and Land Use Solutions "- Winter '24
- CPC created supplemental maps to support the required inventory sections Spring '24
- Levine Planning provided draft inventory sections for Historic Structures, Water Resources, Natural Resources, Agriculture &

Forests, Marine Resources, Recreation, Transportation and Existing Land Use to the CPC - Spring '24

Phase II of the Comprehensive Plan (CP) completed to date includes the following activities and deliverables:

- Levine Planning provides quantitative and qualitative survey summaries to CPC Fall '24
- CPC establishes vision statement based on survey results and community input - Fall '24
- CPC creates goals, objectives, and strategies based on survey results
 Fall/Winter '24
- CPC identifies growth and rural areas based on 10-year population growth, new housing units, and undeveloped parcels - Fall/Winter '24
- CPC hosts two (2) public presentations reviewing plan progress, vision statement, goals, objectives, and growth/rural area identification - Fall/Winter '24
- CPC provides Levine Planning goals, objectives, and growth/rural area identification documents – Winter 2024/2025

The CPC will hold additional informational sessions in 2025, including presentation(s) of the final Comprehensive Plan draft. To ensure the plan benefits from ongoing citizen input, the CPC continues to encourage participation from community members in all aspects of the planning and implementation process.

The committee anticipates presenting the final Comprehensive Plan for town approval during a special Town Meeting in 2025.

As a reminder, the Comprehensive Plan Committee meets together with the Planning Board on the second Tues. of every month at the Sedgwick Town Office. Meetings are open to the public and residents are encouraged to attend.

The CPC gratefully acknowledges the valuable contribution of Donna Beninati who prior to her resignation served as the first chair of the committee.

PENINSULA AMBULANCE CORPS 2024 Report to the Towns

As the effects of COVID waned in 2024, we experienced some new challenges. Staffing continued to be a challenge as full-time employees took leaves as provided under the Family and Medical Leave Act. In addition, inflation increased the cost of providing services. Our business model was able to cope with these challenges and we ended the year in good shape.

With two full-time employees taking time off for personal reasons, we had to use management and overtime to cover their hours. We were able to do this and, in fact, respond to much increased call volume without reducing our coverage. As the year ended, we saw a sudden spike in applications and we have now returned to pre COVID staffing levels.

The cost of doing business has increased as fuel, medical insurance, medical supplies and almost everything we use to provide our services have increased in cost. Our call volume is increasing which results in higher use of fuel and supplies as well as higher insurance reimbursement. Despite these challenges, PAC continued to provide services and adjust our practices to compensate for the increased cost of doing business. In addition, we continue to improve employee wages to remain competitive.

Our largest payor has become Northern Light Health. It accounts for 19% of our total income from patient transports. The new Blue Hill Hospital is now a critical access hospital with limited inpatient and ED beds which means that PAC conducts more transports from our Peninsula to Maine Coast and Eastern Maine hospitals. Movement of patients between hospitals is an important function of EMS. It gets patients to the definitive care they require and frees up local hospital needs for new patients. In addition, the income from interfacility transports helps keep town contributions as low as possible.

Our next 2 largest payors remain Medicare (federal government) and Medicaid/Maine Care (state government). Together, they represent 32% of our payors. However, for every \$1 PAC bills them, they pay only \$0.30 at best. This accounts for most of our operating deficit. If we include all payors, we still are only paid \$0.53 for every \$1 billed. This is a national issue and impacts rural services, such as ours, particularly hard because ambulance services in more densely populated areas can make many more reimbursable calls in a given amount of time. We continue to support state and national efforts to improve EMS reimbursement rates.

We are proud of our nine full-time and fifteen part-time and per-diem Staff—the Paramedics and EMTs who make the program work. They have completed 1818 calls in the last year and have been steadfast during these trying times. We continue to provide Staff with continuing education for federal and state mandated classes. We believe the morale of our staff is high and we know that they provide an invaluable service to PAC's seven communities on the Blue Hill Peninsula. We added three staff members in 2024. EMS staffing is an issue nationwide. We continue to explore recruitment and retention solutions.

Our three ambulances allow us to maintain our staffing model of two on duty ambulances with a spare to use when the others need service. This also allows us to staff the third ambulance for local events, such as the Blue Hill Fair, and at times of peak call volume when we utilize management to staff the third ambulance. This allows us to respond to more calls. Our goal for 2025 is to increase coverage in the 7pm to 11pm period to match the increasing call volume.

Totals by town are displayed in the chart below. We set record call volume in 2024. Inter-hospital patient transports, grew from 35.8% of PAC's total in 2023, to 48% in 2024 and while these are included in the call volume from Blue Hill, the patients transported live throughout the Blue Hill Peninsula.

We cut our deficit in three ways: with the support of our town governments, by individual donations to our annual appeal, and by using unpaid volunteer board members to accomplish many tasks.


This year we are asking for \$24.75 per capita (from the 2020 census) for the operating budget (an increase of \$1.25) and \$8.00 (an increase of \$2.50) for the ambulance reserve fund. This is a total of \$32.75. We are scheduled for an ambulance purchase in 2027 to replace our oldest ambulance which by 2027 will have greater than 200,000 thousand miles on it. We were surprised a few months ago when our vendor notified us that the cost has increased significantly due to inflation, materials costs and labor costs. We experienced an 18% increase with our 2022 purchase. We are expecting at least a 45% increase for the 2027 purchase. This requires an increase in the ambulance replacement fund contribution from the towns with the 2025 budget.

Even though we have returned to pre-COVID staffing levels, we need more Staff and we must keep the people that we have. We must pay our people what they are worth if we are to keep them. Potential new Staff must balance their remarkable dedication to an essential calling with their need to feed their families, pay for heating and keep a roof over their heads. This year's requested increase in operating funds will support staff compensation.

Staff and ambulances are the visible aspects of PAC, but community loyalty and the funds provided by the towns are its lifeblood. Our annual appeal to the public provides an essential and remarkably consistent source of support, but close the remaining gap we have no choice but to rely on the good will of Town governments and the generosity of their taxpayers to understand the invaluable role played by the Peninsula Ambulance Corps.

Superintendent's Report

To the citizens of Sedgwick:

I am pleased to find myself as your Interim Superintendent once again, having previously served in this role in the Winter/Spring of 2022. Your school is in good shape and has a committed Board, a strong staff, and delightful students. Enrollment is not as robust as we'd like, but the school is thriving nevertheless.

Our proposed expenditure budget is down 0.29% or down \$9,911.73 from this year's budget. Even so, we were able to add two days a week of library services, a stipend for theatre/drama, and \$150,000.00 for building capital improvements as the building is now over 30 years old. We were also able to keep the After School Program running.

We expect that State Subsidy will be about \$91,000.00 less for 2025-26 than it is in 2024-25 (\$317,557.72 vs. \$409,047.76). However, the \$317,557.72 is not necessarily a real number yet, and won't be fully settled until the Legislature adjourns in June. Secondary tuition is also down about \$100,000.00 because we are anticipating fewer high school students next year from this year.

We will be applying \$100,000.00 from carry forward to the 2025-26 budget leaving us with approximately a 3% undesignated surplus which is on the low end of our auditor's recommendation, but we are comfortable with this figure.

Even though the expenditure budget is relatively flat, revenues are down (\$91K in State Subsidy, and \$200K in carry forward, as for 2024-25 the Board applied 300K towards the current budget). Thus, depending upon the Municipal budget, Sedgwick citizens could see taxes go up as a result of this proposed school budget.

In closing, thank you for bringing me back here again as your Interim Superintendent. You have a gem of a school in your town, capably headed by Principal Magoon.

George Stevens Academy Head of School



Dear Sedgwick Residents,

As we reflect on the past fiscal year at George Stevens Academy (ending June 30, 2024), I want to share some encouraging updates on the school's improving financial position. GSA has long been a cornerstone of our community, and we are deeply grateful for the continued support from our sending towns, families, alumni, and friends. Your investment in our students ensures that we can provide a well-rounded education that prepares them for success in college, careers, and life.

Once again, we extend our appreciation to the citizens of our sending towns for approving supplemental tuition beyond the state's maximum for the 2023-2024 school year. Public funds, including town-approved supplemental tuition, made up 87% of our total revenue when factoring in donations from supporters, or 73% without those contributions.

For FY24, total tuition, fees, and reimbursements amounted to \$4,284,115. Additional operating revenues came from fundraising with \$823,578 in unrestricted and restricted gifts and \$470,746 from the endowment, as detailed in our audited financial statements available on the GSA website.

One of the most significant financial improvements at GSA was that we finished the year with a \$86,180 operating surplus. While this was not a large reserve, it represents a substantial shift in the right direction. Given the financial challenges of past years, ending the year in the black was a meaningful and promising accomplishment. We remain committed to careful financial planning and responsible budgeting to sustain this positive trajectory.

The 2023-2024 education cost for our student body ended up at a total of \$5,562,729. The 2023-2024 state tuition rate, approved in December 2023, accounted for \$13,300.12 per student, with an additional \$798.01 per student through the state's Insured Value Factor (IVF). Town approved supplemental tuition accounted for \$414,407.

Philanthropy continued to play a vital role in GSA's financial health. Thanks to the generosity of alumni, families, and community members, our fundraising remains strong year after year, helping sustain programs that serve students with a variety of academic and career aspirations. In total, \$832,578 in charitable gifts were received last fiscal year, including funds for scholarships. This generosity strengthens GSA's ability to provide exceptional opportunities for students across the peninsula.

Last year's supplemental tuition request was also approved by a strong majority of voters. We are incredibly thankful for that trust and support from our community, as these funds have been vital for this year's budget. Your commitment to GSA allows us to continue our mission of providing a high-quality education while maintaining responsible financial stewardship, now and into the future.

Report on the Audit of the Financial Statements

Opinions

We have audited the accompanying financial statements of the governmental activities, each major fund and the aggregate remaining fund information of the Town of Sedgwick, Maine (the Town) as of and for the year ended June 30, 2023, including the related notes to the financial statements, as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, each major fund and the aggregate remaining fund information of the Town of Sedgwick, Maine as of June 30, 2023, and the respective changes in financial position thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinions

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the accompanying supplementary information is fairly stated, in all material respects, in relation to the basic financial statements as a whole.
